# Certificate of Inspection

Vessel Name: STORM CAT

This Certificate of Inspection (COI) is issued in consideration of the provisions contained in 46 U.S.C. 3103 and 46 CFR Part 139, on the basis of reports, documents and records provided by Towing Vessel Inspection Bureau (TVIB), an approved Third Party Organization, and the vessel's possession of a valid Coast Guard Decal.

This COI is issued in consideration of the provisions contained in 46 CFR 138, based on objective evidence provided by (insert name of TPO), an approved Third Party Organization, and the vessel possesses a valid TSMS Certificate for the existing safety management system used on the vessel.

This vessel operates under a Towing Safety Management System (TSMS) Certificate issued by TVIB, utilizing an internal survey program, as per 46 CFR 137.210 to ensure compliance with Subchapter M.

**LIFESAVING:** Vessel complies with 46 CFR 141.305(d)(3)(ii) TSMS Evacuation Procedures and is not required to carry a survival craft when operating solely on a rivers route. Lifejackets shall be immediately available for persons at each normally manned watch station.

**FIREFIGHTING:** In addition to the required portable fire extinguishers listed on this COI under Fire Fighting Equipment, one (1) 40-B portable fire extinguisher must be located near each flammable storage locker as per 46 CFR 142.225(d).

On existing vessels built or contracted for prior to August 22, 2016, previously approved extinguishers may be retained through the extinguishers' serviceable life. However, once the extinguisher requires replacement, or is voluntarily replaced, the extinguisher must meet the appropriate performance rating type and size specified in 46 CFR 142.230.

**FRESH WATER ENDORSEMENT:** This vessel has been granted a fresh water service examination interval in accordance with 46 CFR 137.300(a)(2) and D8 Policy Letter 08-2000. If this vessel is operated in salt water more than 6 months in any 12 month period, the vessel must be inspected using salt water intervals per 46 CFR 137.300(a)(1) and the cognizant OCMI must be notified in writing as soon as this change in status occurs.

**MID-STREAM FUELING OPERATIONS:** While engaged in mid-stream fueling operations the Person In Charge (PIC) must have a valid Transportation Worker Identification Card (TWIC) and Merchant Mariner Credential (MMC) endorsed as a Tankerman or a Restricted Tankerman Endorsement for Dangerous Liquids (DL) or Liquefied Gas (LG) per 33 CFR 155.710.

**STABILITY:** Prior to getting underway, the Master or Officer in Charge of a Navigational Watch shall ensure that the vessel is at all times maintained and operated so the watertight integrity and stability are not compromised as per 46 CFR 140.605.
